Filed Pursuant to ALGOP Rules Governing Candidate Qualifications and Ballot Access

I respectfully submit this challenge pursuant to the **Alabama Republican Party Rules**, specifically the provisions governing **denial of ballot access** based on prior and continuing affiliation with another political party.

Applicable Rule

The Alabama Republican Party Rules provide that ballot access **shall be denied**, except by the required supermajority vote, to any candidate who within the applicable look-back period has:

- **Voted or run in the primary of another political party;**
- **Publicly supported another political party or a nominee of another political party;**
- **Financially contributed to another political party or candidate;**
- **Been financially compensated by another political party or candidate; or**
- **Been a member, officer, or active participant in efforts aligned with another political party,**

where such conduct demonstrates a lack of bona fide affiliation with the Republican Party. (The Rule further provides that this prohibition applies for **six (6) years** following such participation and may also be considered when conduct demonstrates a **continuing relationship or ongoing political alignment**.)

Grounds for Challenge

1. Paid Political Work for a Democratic Candidate

In 2018, Jesse Battles was **financially compensated by Democrat Craig Ford** to assist in Ford's campaign against Republican candidate Andrew Jones.

Mr. Battles has **publicly admitted** to this paid political work on social media.

This conduct constitutes **financially compensated participation in the campaign of another political party's nominee**, triggering the Rule's prohibition.

2. Public Support and Active Association With Democratic Officials

Documented evidence included with this filing shows Jesse Battles has **publicly supported, campaigned with, and appeared at political events and fundraisers** alongside:

- Former Democratic Senator Larry Means; and
- Former Democratic House Minority Leader Craig Ford.

Mr. Battles and Larry Means **actively campaigned together for months**, including coordinated travel during overlapping political efforts.

Mr. Battles publicly stated to Larry Means:

"Thank you for your encouragement and support. I am committed to staying humble and working alongside you and our elected officials."

This constitutes **public support and political cooperation** with Democratic officeholders and leaders, in violation of the Rule.

3. Continuing Relationship Demonstrating Ongoing Alignment

Although the initial paid activity occurred in 2018, the Rule does not require the Committee to ignore **continuing conduct** that demonstrates an ongoing political relationship or lack of separation from another party.

Mr. Battles' actions—particularly within the past year—show **no repudiation, no disengagement, and no meaningful break** from Democratic political actors who previously controlled Senate District 10.

Further, as recently as **2022**, Democrat Craig Ford employed **Melissa Battles**, the candidate's spouse, as his executive assistant, reinforcing the **recency and continuity** of this political relationship.

4. Strategic Impact on Republican Party Integrity

District 10 was held by Democrats for decades and only came under Republican control through sustained effort by Republican activists and elected officials.

Permitting a candidate with **documented, ongoing Democratic political relationships** to appear on the Republican ballot creates a material risk of **restoring Democratic influence** through a Republican primary—an outcome the Rule is designed to prevent.

Conclusion and Relief Requested

The evidence establishes that Jesse Battles:

- Was **financially compensated** by a Democratic candidate;
- **Publicly supported and politically cooperated** with Democratic officeholders; and
- Maintains **continuing political relationships** inconsistent with bona fide Republican affiliation.

Accordingly, I respectfully request that Jesse Battles be **denied ballot access** as a Republican candidate for Alabama Senate District 10 in order to preserve the integrity, loyalty, and purpose of the Republican Party.

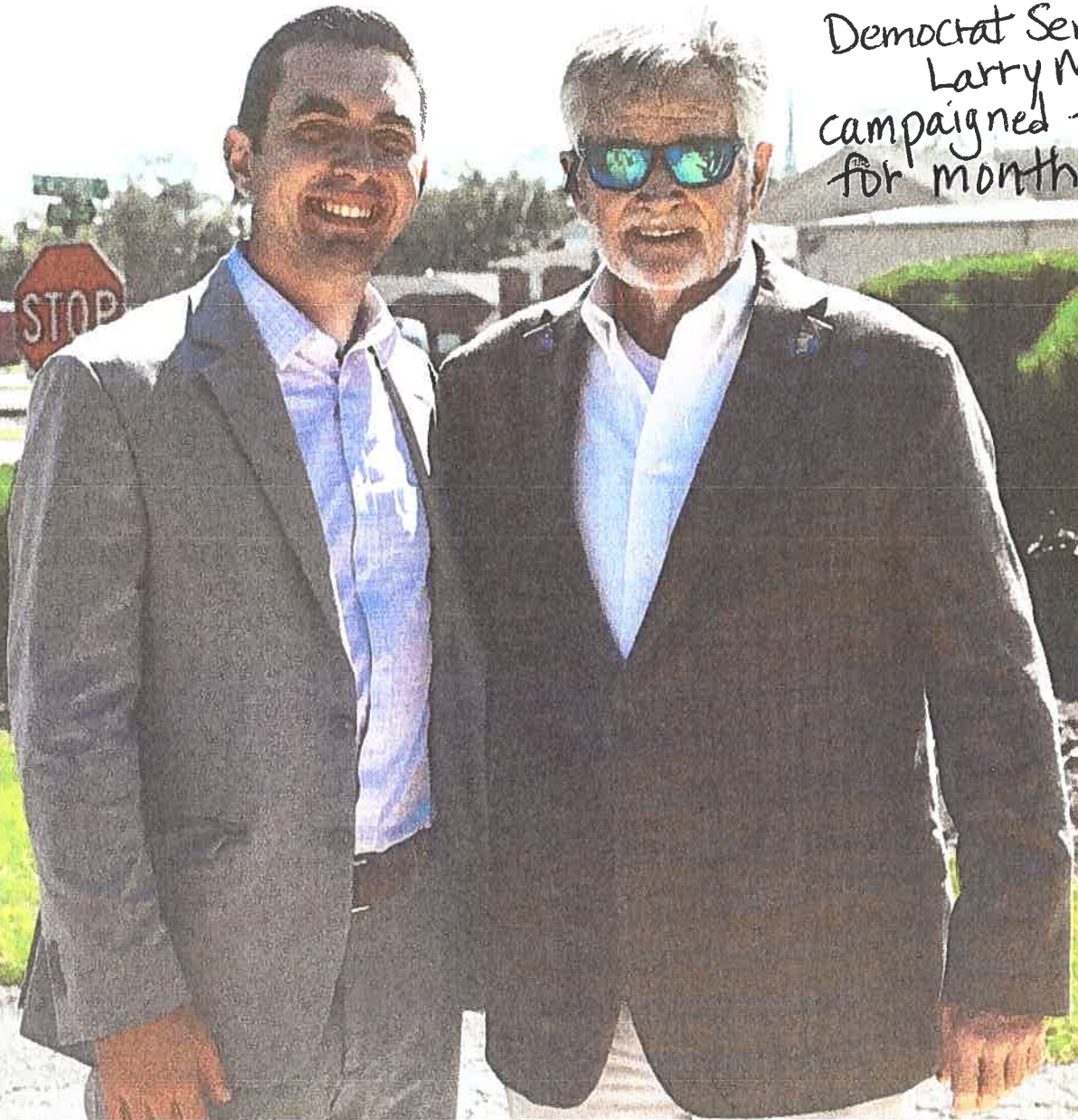

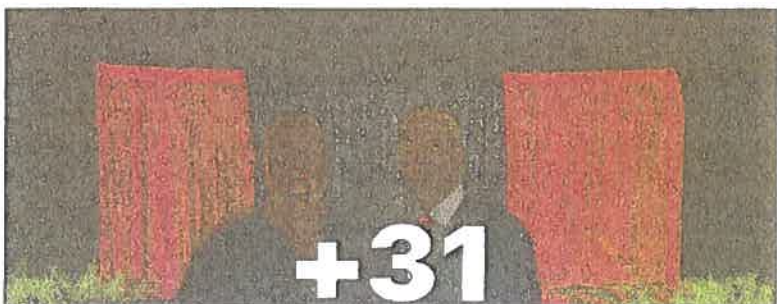

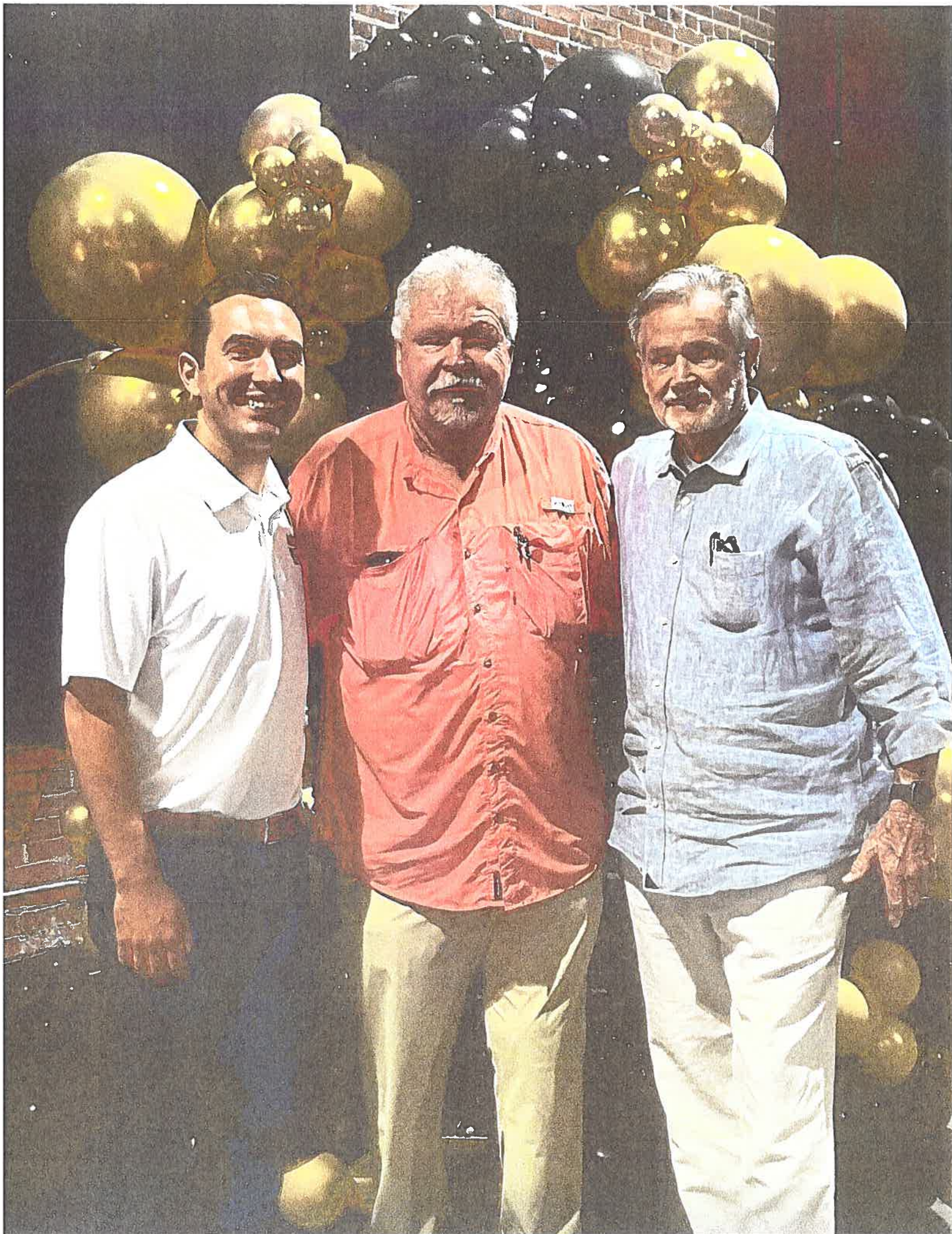
